Of typhus fever, Thursday night, at the North Monastery, Cork, Gerald Griffin, Esq. late of this City, author of "The Collegians," "Tales of the Munster Festivals," and other works of high literary merit. The fame of this regretted gentleman will descend to posterity. Few, or perhaps none of his compers could excel him in the peculiar beauty and chaste style of composition for which his works are celebrated. Morality, religion, and patriotism, each "the purest and brightest," animated the writer, and shone with happy lustre through every page of his productions. Admiring friends and countrymen deplored the loss, but he preferred Gon to wordly honour and temporal riches. His life was that of a good Christian—his end, the death of the righreous.
