That active Police officer, Constable Slattery, of the Patrick's-well station, arrested in the County Court-House, yesterday, Thomas Bailey, one of the persons concerned in the attack on the house of Edward John Croker, Esq. at Grange hill (particulars of which appeared in the Chronicle.) He was fully identified by Mr. Croker's servant, and is now committed for trial to the County gaol by W. S. Tracy, Esq. S.M. before whom the informations were taken. When Bailey observed the Policeman looking at him closely in the hall of the Courthouse, he ran behind the large van or machine used for the conveyance of prisoners to and from the County prison, from whence he was taken by Slattery, and brought before the Magistrates on the bench.

Richard Mangan, labourer, employed in a timber yard at Bedford-row, while removing a weighty beam with three other men on Wednesday, one of them lost his hold, and the others let go, when the entire weight of the beam fell upon Mangan, fractured his left thigh, and crushed his intestines.
