who told him if he did not stand back he would run him through, the man went back a little; the man came again to the front of the mob, and the soldier stabbed him in the breast with the point of the bayonet; the soldier advanced at a quick pace from amongst the other soldiers; there was the length of the musket and perhaps a yard between the soldier and the man, who fell back when he was stabbed; I am not sure that I should know that soldier again (here witness looked at the prisoner, but said he was not sure that he was the man.)

Cross-examined by Mr. Rolleston--The soldiers were obliged to go slow on the road, on account of the crowd which encreased as they came forward to the town; the people kept pushing in to have a view; those behind pressed them; they were calling the soldiers a variety of bad names, there were people climbing up on cars about the bridewell yard.

Other witnesses were examined in this case to similar effect. The judge detailed the evidence at considerable length, after which the jury retired and returned a verdict of Guilty of a common assault committed in discharge of his duty.

SENTENCES OF PRISONERS.

Judge Crampton passed sentence on a number of prisoners.
