Thursday morning the sons went to Bray Head for exercise, and on the top of one of the cliffs the ill-fated young gentleman's hat was blown off, and in endeavouring to regain it, or from his foot having slipped, he fell over the cliff, and in the fall the skull was fractured, and he was killed on the instant! He was but 17 years of age, of the highest promise in talent, and of most amiable disposition. He had received the rite of confirmation from the Archbishop of Dublin, on Wednesday.
