Now the reading of the foregoing "simple fact

if left uncontradicted, would lead to conclusions w far from fact. First, it would lead the Dub Public to conclude that the United General Gas Co pany supplied Gas by Meters generally in the City Limerick subsequently to the New Company startis Such is not the fact; their refusal to supply by Me was one out of the many reasons which called I New Company into existence. I am aware they tri to supply two or three Establishments by Meter, a were only successful in one instance, and althou the supply by Meter was nominally 10s, the scale i contract Lighting was calculated at, and above 15 per thousand feet.

The second assertion, "that the New Compan charge to this hour 10s 10d. per thousand feet," also incorrect. The price at present charged, as since 30th September last, is 9s. 2d. per thousas feet, and to very large consumers a further reduction is made. This reduction was made, regardless of the price charged by the old Company. The Directors the new Company conceiving from the extent of the connections, the rapid increase of consumption, ar the improved method of generating Gas that a r duction from 10s 10d. to 9s. 2d. might safely l made, it was therefore considered right that the Public should get the benefit of it, and the reduction was made accordingly.

The third assertion, "that the New Company hav obtained a higher price for the public lights," is als incorrect. Tenders were called for by the Con missioners for Public Lights in May last for two year from 1st October. Tenders were accordingly sent i to the Board of Commissioners, and that from th United General Gas Company was rejected, being three shillings per lamp over the tender from the presen Contractors, the price now paid being £3 15s for eac lamp, burning four feet of gas per hour, 365 night in the year, from sunset to sunrise, the tenders of th United General was £3 18s. for the same. This ha reference only to the parish of St. Michael, for i other parts of the borough the United General Ga Company required £4 4s. per lamp, though thos portions also are now let by the new Company fo £3 15s.

The last assertion I have now to deal with, namely

"That the posts, columns, and lamps, are furnished in Limerick at the expense of the Commissioners Such is not the fact, but false in every respect, as a the posts, columns, and lamps now in use, as well in the parish of St. Michael's as in all other parts o the borough of Limerick, are the property and have been supplied at the sole expense of the presen Contractors. It will now be seen how evanescent the statements are respecting the 'Limerick Consumers Company" and its concerns. By the way, may ask if this address be really from the Hibernian Gas Company? and how are they effected by the Limerick Gas Consumers's Company? Surely they have no establishment in this City! I hope the citizens of Dublin will pause before they enter into any contrac with any company—a reduction of twenty per cen on the price of gas supplied by meter may be a great sacrifice to a company, but that will depend upon the quantity supplied by meter. I see no proposition to reduce the scale of prices for contract lights, the reduction in Limerick by the old Company on those prices is thirty five per cent.

In conclusion, I may remark that gas - supplied by meter at 8s. per thousand feet manufactured on the old principle and system of purification, will be found much dearer than gas at 10s per thousand, manufactured from good coals on the new principle and thoroughly purified.
