about six o'clock, while drawing for salmon near

Palmer's Creek, below Barrington's-quay, two of the Abbey fishermen, named Lyddy, caught a splendid Sturgeon in their nett, measuring eight feet in length, four feet in circumference, and weighing 21 cwt. When first the fish got entangled in the nett it struggled a little; but, when the fishermen endeavoured to draw it in (not knowing what it was), it plunged most violently, so as to force their cots under water. Luckily, other fishermen came up just as they were about relinquishing the prisoner, and by their united exertions, after getting a few dips in the attempt, succeeded in bringing it ashore, not however without considerable difficulty. Shortly after the sturgeon was conveyed to Mr. Francis P. Russell's store, in Saint Francis's Abbey, it remained for the day an object of curiosity to thousands who flocked to see it. The Sturgeon, in colour, is rather darker then a salmon, though similarly formed and spotted; it has no sign of mouth, and sustains itself by suction, through an opening under the neck, the head being small in proportion to the . The Mayor approved of sending it as a present to Daniel O'Connell, and it was last evening paraded through the streets upon a door on men's shoulders, with a temporary deal case before it, exactly in the form of a coffin, in which the dead Sturgeon, was nailed up, and forwarded this morning, on the roof of the Day-coach, to Richmond bridewell. Breathe not to "ears polite," the proper name of this monstrous present, when it shall arrive in the metropolis! The strange visitor will not be admissible to the prison before one o'clock on Monday, and, in this sultry weather, four days must greatly alter the constitution of its hugebulk.
