the evidence, he was decidenty of opinion testator was fully competent not only to make a will, but this very will now propounded. He might be mistaken, but it was his decided opinion that the testator could exercise rational and consecutive thought on subjects of importance.

The Court was thus divided in opinion, having been three to two. Doctor Longfield, Baron Richards, and Judge Crampton, were in favor of declaring only part of the will valid. Judge Burton and Sir Thomas Staples in favour of the Court below, and declaring the whole valid.

The Earl of St. Germans, father of Lord Eliot, Chief Secretary for Ireland, expired on Sunday, at his seat Fort Eliot, St. Germans, Cornwall, in the 78th year of his age. He is succeeded by his son Lord Eliot, whose elevation to the Peerage creates a vacancy in the representation of East Cornwall, and in the office he holds at Dublin Castle. Lord Eliot sailed from Dublin yesterday to attend the funeral of his father.

James Wherland, Esq. was yesterday found dead in a pool of blood, at the Cove-street Lying-in Hospital, Cork. On examination, it was found that he had shot himself thro' the head, and the fatal pistol was found by his side. The deceased, a medical gentleman, held four public offices of considerable emolument, viz .- Secretary to the Cork Annuity Endowment Society, Revisor of the Cork Union, Inspector of Weights and Measures,

and Inspector of the Corn Market. Yesterday, John Brown, of Belmont, Esq. a magistrate of this county, received by the Castle-Connell post-office a letter, threatening him with the awful fate of Mr. Gloster, should he dare set a small farm at Rabbit-hill, to a man of the name of Michael Byrnes, from Doonass, and devoting both him and Byrnes to a cruel death. This is an apt commentary upon the Kilballyowen outrage, and directly tends to expatriate good resident landlords. Mr. Brown is an active, resolute magistrate, but also a gentleman of the most kindly

feeling, and truly benevolent disposition.

Monday evening last, at an early hour, the houses of Jeremiah Scanlan, and James Molony, respectable farmers, at Ardclony, near O'Brien's Bridge, were attacked by a party of armed men, who took from the former one gun, and one gun with a case of pistols from the latter, who was then in Limerick, or the marauders would not have got off so easily with their prize.

Mr. Samuel Smith, a respectable Protestant farmer, formerly of Lisduff, near Moneygall, but latterly a resident of Dublin, was brutally murdered on Saturday last, between 3 and 4 o'clock, afternoon, on the road near Whiteville. His skull was broken with stones. He came down to collect rents from some tenants who were backward in their payments. Sunday evening, an inquest was held on his body by Michael Cormack, Esq. coroner, when a verdict of "wilful murder" was returned against some persons unknown. Mr. Smith was 72 years of age, and when discovered, was lying on his side in the ditch, with his head resting on a large stone, which was perfectly deluged with blood proceeding from his wounds, which were four in number. Of these, one was at the back of the head, where the skull was fractured and the scalp torn. Mr. Smith was not only inoffensive in his bearing, but benevolent in his disposition, liberal in his acts, and one of the very last on whom the assassin's vengeance should be supposed to fall.

The Parish Church of Kilruane, near Nenagh, was broken open on Sunday morning and all the windows of the Church and the entrance gates smashed to pieces. The dwellings of two men in the employment of the Rev. W. B. Fry, incumbent of the Parish, were fired into a short time since, and the men ordered to quit.
