SUPPLY OF WATER IN LIMERICK.

There was not a full board yesterday of St. Michael's parish commissioners, but the few who had assembled directed the following correspondence should be published to shew the inhabitants that the commissioners are alive to the importance of having a sufficient quantity of water at their command, in case of fire since the conflagration at Mr. Burgess' last June :--

" Limerick, St. Michael's Parish Office, June 28, 1845.

"SIR-The Commissioners for improving the Parish of St. Michael, beg leave to apply to you on behalf of the inhabitants of this extensive district on a subject of the first importance, as regards the safety and preservation of the property of the citizens of Limerick, namely, "a supply of water in the event of a fire."

"Several destructive fires have, within a recent period, occurred here-one on last Sunday morning, 22d est, at Upper Cecil-street, which destroyed property to a very considerable amount. Had it taken place at night, no doubt exists, but that the entire square of buildings in the neighbourhood would have

fallen a sacrafice to the flames.

To procure a supply of water from the mains, a mese senger must proceed hence to the tanks, distant a milfrom the town, and return another mile before the water can be turned on; in the interim entire houses may be burned to the ground before an engine could be supplied. The directors of the Water Company, it is respectfully assumed, will admit that this arrangement for obtaining a supply of water in the event of a fire, requires immediate revision. It can be easily accomplished without damage to the interests of the company, or calling for the expenditure of a shilling. The Commissioners suggest that instead of shutting off the water at the tanks, that the great feeding main in connexion with those tanks, be at all times left charged with water to the head of Upper William-street, where the main valves are situated, and that a key for those valves be left with a careful, well-instructed officer, who would have it in his power instantly turn on the supply of water to the district of the city where the fire may appear.

This simple arrangement, if carried out, will remove many causes of complaint, afford confidence to the habitants, and be the means of saving and preserving

the property of the citizens.

The Commissioners are desirous of trusting in the disposition of the Water Company to meet the views and wishes of the people of Limerick, on whose behalf the Commisssioners make this appeal.

Although we have enjoyed no countenance or encouragement whatever from the authorities of Limeick, and have hitherto been left without any return for the large investment of capital which we were induced embark, by so many unfulfilled promises of support, shall, nevertheless, confer with our agent as to the bacticability of establishing any more desirable system han that now pursued, without entailing on the Company any additional loss.
