a number of country people appeared on the shore. It was then for the first time ascertained where they were. They were in Ballycotton bay, and the Sirius lay on the rocks in Ware Cove, so named from a vessel called the Ware having been lost there many years ago. The Ballycotton coast guard boat and two fishermens' boats hove in sight. They immediately proceeded to take the people from the ship, which was a service of great danger, as the surf prevented their going alongside, and they had to row quickly by the vessel, and catch each person as he fell from above them .-By this means all, with the exception of the mate, who remained on board, were removed from the ship, and those on the rock were taken ashore by the rope and lifebuoy. The passengers being landed, the fishermen and country people got into the ship and commenced pillaging her, heedless of the coast guard officers, and continued during the day until a large body of police were brought in from the country, and 200 Marines from Cove.-None of the clothing or luggage of any of the passengers has been saved, being either stolen or washed out of the vessel. The cargo is lost, and the vessel is a total wreck. The cargo was estimated at £30,000, and the vessel at £15,000. The latter was insured for £10,000.
