bill passed, there were many in Dublin uninnuenced by commercial or professional duty—and he was one of that class-who would leave it, and go and reside elsewhere; and he was of opinion such men should be encouraged to live in Dublin. He candidly avowed that if the proposed bill became law he would on the next day, sell his house in Mountjoy-square, and abandon the metropolis, which he lived in perhaps more as a source of pleasure than otherwise, for there were other places that might better conduce to his feelings as more suitable residences (hear); and in saying so he could tell the government that he spoke not his own individual opinion, but the opinions of a large class of persons, whom he had conversed with on the subject; in fact, what he had put forward was the universal op inion that if the proposed bill passed, they could not reside in the city of Dublin.

Yesterday, Edward Farrell, Joseph Farrell, his son Christopher Flynn, and Michael Hill, went out in a boat from Malahide to fish, and when crossing the bar the boat was upset, and the unfortunate men drowned.

Iu the libel case of the Sligo Champion v. Sligo Journal, newspaper, the jury were yesterday discharged in the Queen's Bench without a verdict. The detence set up was, that the complainant had libelled the defendant as well.

Mr. George M'Cleery, of Cumber, died at the advanced age of 113 years, on Sunday. He was the oldest Orangeman in Ireland, having joined that society previous to the battle of the Diamond.
