Wednesday, a party attacked the house of John Purcell, of Doonane, Queen's County, and after demanding admission in the name of the police, they forced an entrance and rushed into the bedroom, where Purcell's wife was sleeping (her husband being from home) and demanded £50 which she had received. Constable Conroy, of Newtown with a small party, who was lying in wait pounced on the robbers and secured them. The robbers were committed to Maryborough gaol. One of them, Patrick Nash, was overseer in the Colliery at 2s 4d. per day.

Mr. John Kelly, a respectable farmer, of St. Mullins, Carlow, was murdered on Sunday last, after returning from Church, by a man of the name of Helihan, who has absconded.

One hundred and eighty gentlemen obtained various degrees in Trinity College, Dublin, yesterday. The Provost, Judge of the Prerogative Court, and several Fellows presided.

The Society of Friends in this city sent on Saturday a ton and a-half of Indian meal to Ballybunnion, for the relief of the poor. Four of the Society are now on a mission through Clare, to ascertain the wants of the destitute and to afford relief.

A respectable farmer of the name of Hogan, riding home to Rathcannon, in this county, fell from his horse into a dyke or drain at the road side, and was suffocated.

Mr. T. Haines is elected a town-commissioner of Mallow in room of Mr. Corbett.

The Odd Fellows branch Society of Cork have given £50 to the relief committee of that city.

Mr. O'Shaughnessy is appointed clerk of the reorganised Cork relief committee.

The magnificent iron bridge at Monastereven was yesterday set up, in presence of the Directors of the Great Western Railway. A splendid dejeuner was given on the occasion.

Sir John Nugent Humble, Bart., of Cloncoskoran, Dungarvan, High Sheriff of the county of Waterford, has appointed Edward Foley, Esq., of Lismore, his Under Sheriff.

On Monday, an inquest was held at Patrick's-well, by James Bennett, Esq. Coroner, assisted by Clement Peat, Esq. M.D., upon the body of a man named Enright, who, it appeared in evidence, came from near Cappamore, and trusted to charity for support; that he was exposed to great hardships this inclement season, which brought on dysentery, and caused death, immediately after arriving in Patrick's-well. Doctor Peat was examined, and a verdict returned in accordance with his testimony, that deceased came by his death from insufficiency of food.

On Friday, a bailiff, Robert Hynes, a pensioner, laid a seizure on a man named Brennan, who resides in the Pollerton road, Carlow. He attempted to force an entrance, when Brennan stabbed him with a pitchfork near the eye, the wound penetrating the brain, and proved fatal.
