So great has been the labour undergone by the Roman Catholic clergymen of Tralee, that the Parish Priest, Rev. Dr. M'Ennery, had to go through all the religious duties without assistance, his curates having been laid down by death or disease-the Rev. Mr. Enright having just fallen a victim to typhus fever, Rev. Mr. Fo'ey lying almost hopelessly ill of the same; the Rev. Mr. Mawe is also knocked up by excessive labour-Kerry Post.

Mr. Maurice O'Connell, M.P. states that a large proportion of oats, barley, and potatoes have been sown in Iveragh; and that the people are seen in daily increasing numbers at work in the fields.

In the district leading from Galway to Dublin almost the entire of the ground is laid down with wheat, oats, barley, and potatoes.

The country in the neighbourhood of Cork presents a most pleasing appearance. Vegetation advances rapidly and healthfully. On the whole, the prospects of the harvest are encouraging. About one-half the usual extent has been planted with potatoes and much more than the ordinary quantity with corn.

The largest turnip crop ever sown in Ireland is now in the ground, and an immense produce is anticipated.

If the fatal blight does not fall upon the potatoe fields this summer, the best crops ever grown will be produced, as farmers took extraordinary care in preparing the ground and selecting seed.

Doctors Barker, Curtin, and Wherland, of Cork, have come out with a declaration in favor of Water cure treatment of patients.

The Crusheen relief committee had not a pound to expend on Saturday, when Austen Butler, Esq. of Bally line, advanced them £50 to provide a supply of food for the poor of the district. On the Lanesboro' estate the Lord Chancellor has

approved the expenditure of £320 to enable tenants to

The British Relief Association have placed bread stuffs to the value of £1000, at the disposal of the Mayor of Cork, Dean Newman, and Father Mathew, for the destitute poor.

Two barrels of clothing, one barrel barley, and one barrel potatoes, for Miss J. Bruce, Prohurst, Charleville, for poor relief, were shipped on the 28th ult. per the Josephine, at Boston, for the Cove of Cork.

It is disgusting to see Irish characters so frightfully maligned on the British stage. Every new piece of the sort is brought forward to lower the national character ; even London is beginning to surfeit of the absurdity. "The Irish Post," now representing at the Haymarket, is apparently got up to turn unhappy Ireland into ridicule and contempt. How far different is any dramatic work written on Scotland, always, and very properly, designed to exalt the people, and leave their scoffers no food for detraction.

At Skibbereen Quarter Sessions, before Mr. Assistant-Barrister Moody, there were 300 prisoners for trial. Twenty-one were in fever, one of whom died on Friday. The majority of the prisoners were charged with stealing cows, sheep, &c.

Trade is so bad in Cork, under famine and disease, that many shopkeepers are obliged to subsist upon their present stock, and some of this not paid for; no business doing unless in bread stuffs.
