pledge ought to be taken by any candidate who offered. The Mr. Rev. Costelloe said Mr. Powell was ready to pledge against taking place, or soliciting it for his friends, unless it was the wish of his constituents.

Mr. J. Ryan, of Bruree, said that Mr. Power had taken the pledge alluded to in Cork, and that he had returned to vote for him in consequence of having done so.

Mr. Devitt-I deny it-he never took such a pledge. The next resolution (condemnatory of disunion, and recommending unanimity) was proposed by Mr. Dowling, and seconded by the Rev. Daniel Synan, P.P. of Thomondgate, who expressed a hope that from that day forward they may never hear of Young and Old Ireland, but that all would unite for the country.

Mr. Russell was then moved from the chair, and Capt. Kane called thereto, when thanks were voted to the former gentleman, and the meeting broke up.

On leaving Quinlivan's hotel, those who were supposed to be "Young Irelanders" were hissed and groaned by the crowds in the streets. One gentleman was threatened with a clenched fist to his face.

The following appeared in part of last impression : LIMERICK ASSIZES. OPENING OF THE COMMISSION.

This afternoon, at five o'clock, Baron Lefroy and Judge Jackson arrived in Limerick from Ennis, attended by the city and county High Sheriffs, their officers, and a police escort. Two Grenadiers of the 70th were posted at their Lordships' lodgings in George's-street, to render the usual honours. At six o'clock, the Judges proceeded to court to open the Commission, accompanied by the Mayor, Sheriffs, and preceded by the Serjeants at Mace and Constables, in full regalia.

Baron Lefroy, after the Commission was read, said-Mr. Foreman and Gentlemen of the Grand Jury of the County of the City of Limerick, I was detained a little beyond the appointed time for opening the Commission here owing to the exceedingly heavy calendar at Ennis assizes, which encreased from the time I was first furnished with a return of the cases, when fixing the assizes, from 27 cases to 91, and the number of prisoners from 33 to 111. I hope this explanation will be sufficient apology for being late as to time. I am happy there is no occasion for me to allude to the state of your calendar-in truth I have nothing to offer but congratulation, as there are but eleven prisoners for trial, and only one case which can be considered more than inconsiderable larceny. In the single case alluded to, it appears a death has occurred, but on inquiry I am glad to inform you that it is of such a character as to give you very little trouble, should a bill be sent up by the Crown. Gentlemen, I have also to congratulate you, not only on the peace of your city, as appears by the calendar, but on the state of health of the prisoners in gaol. Of those for trial there is not one sick, and of the number under sentence there are only two in hospital-one is now convalescent, and the other going on favourably. I am happy to be able to meet you under such pleasing circumstances, as there are recollections connected with this city which shall at all times make me interested for its welfare and prosperity* I will not detain you now, gentlemen, if you think fit, but if it is your wish I will take the presentments.

The Foreman said they were ready, and the present-

ments were accordingly flated.

The Court adjourned to ten on Monday. * The learned Baron is a native of this City, and so is his learned colleague, Judge Jackson.

Mr. Justice Jackson entered the county court where the Grand Jury were re-sworn for crown business. Having accounted for his being detained beyond the hour appointed, his Lordship proceeded to congratulate the Jury upon the signs of returning prosperity, after the dreadful calamity with which the country had been visited. The Queen and the people had humbled themselves in fasting and prayer, and Gop had heard them in mercy; and therefore they were now met under happier circumstances. But he could not congratulate them on the state of the calendar. as of murder alone, there were 16 cases, and the other cases of crime were of a very serious character. There were in all 142 cases on the calendar. His lordship concluded, by saying he hoped the Grand Jury would

be ready with the Presentments on Monday morning. The Court then adjourned to 10 o'clock on Monday.
