LIMERICK UNION .- The Guardians met to-day .-Alderman Wallnutt presiding. Mr. Assistant-Commissioner Hancock read a communication stating that the list of orphans in the workhouse, desirous of emigrating to Australia, had been referred to Lieut. Henry, Colonial Emigration Agent, and that none but females could be sent out. A memorial which had been forwarded to the Lord Lieutenant by the disemployed linen and cotton weavers of this city, praying his Excellency may authorise the guardians to afford them the means of emigrating to America, was also read by the Assistant-Commissioner; but, on reference to the Act, it was found the board had no discretion in the matter. as the applicants were not inmates of the workhouse. The Chairman said, the only way to enable them to emigrate was by getting up a public subscription. A letter having been received from the Commissioners, disapproving of the appointment of Mr. H. Hannan. as valuator for that portion of the union comprised within the electoral division of Clare, on the grounds that is not desirable that a portion only of the Union should be revised, It was ordered that no steps be taken by Mr. Hannan for the present. master reported that the paupers had evinced symptoms of insubordination this morning, and became so uproarious that he dreaded personal danger to himself and the officers, consequent upon an outcry raised against the dietary supplied for breakfast and dinner. A committee was appointed to investigate the matter, and report upon the expediency of altering present scale of dietary. There were five candidates for the situation of schoolmistress, viz.: —Mrs. Catherine Denehy Hayes, Kilfinnan; Mrs. C. M'Namara, a native of England; Miss Julia A. M. Bourke, Mountshannon; Miss Ann Donovan, Loughmore; Miss Maryanne Hayes, (acting pro tem) recommended by Mrs. Moore, of the Convent of Mercy. Miss Boorke and Miss Hayes were only put in nomination, and the number of votes being equal for each, the appointment was postponed to this day fortnight. In the house, 2,416 paupers; admitted during the week, 255; discharged, 201; died, 12. Average weekly cost of a pauper, 1s. 3d.

MEETING OF RATE PAYERS AT ENNISTYMON.

A meeting of the magistrates and ratepayers of the Ennistymon Union was appointed for Thursday last, to devise means, as stated in the requisition, of saving the property of the union from confiscation, and provide sufficient relief for the destitute.

The last rate for the union exceeded £14,000, and that sum was to be levied not by instalments but in one payment.

word of this meeting until the previous day.

adjourn the present meeting in order that the various parts of the union might have due notice of it.

Mr. Calcutt agreed with Mr. Patterson in the propriety of adjourning the meeting.

Mr, Rorke observed that if any specific charges were to be brought against the Vice Guardians, he requested as a matter of courtesy, that they should be furnished with a copy of them.

It was then moved by Mr. Calcutt that the meeting adjourn until the 1st of June, which was carried unanimously, and the meeting separated.
