DREADFUL MURDER.—An appalling murder was perpetrated at Cappanihane, in this county, on Monday night last, on the person of Thomas Walsh, a farm servant in the employ of Denis Long. It appears, on an inquisition taken before John Cox, Esq., Coroner, assisted by Robert Fetherstone, Esq., J.P., that Long having returned from the fair of Rathkeale late in the evening, partly under the influence of liquor, and suspecting that improper intercourse subsisted between deceased and his wife, deliberately murdered him, by inflicting several blows with a spade on the head of his unthinking victim while he lay asleep in a settlebed in the kitchen. Doctor O'Kreffe, of Bruree, made a post mortem examination, and found the skull literally broken to pieces; the jury found a verdict in accordance, and Long has been fully committed by Robert Fetherston, Esq., who had him in costody shortly after the perpetration of the murder. Nothing appeared in evidence to justify Long's suspicion, or to inculpate the

wife of the murderer.

James Hennessy, farmer, of Goldengrove, near Dundrum, went out at an early hour on Wednesday morning to count his stock in the fields, as usual after the night, and his servant girl having followed her master in about an hour after, found him dead near a ditch, from two gun shot wounds in the head and body. His brother, a land bailiff, was murdered about 9 years ago. The lands of Kilpatrick was the scene of the murder of the former.
