The Barony Constables for Kerry were re-appointed last Assizes with the exception of Mr. James Butler, for Iveragh, who resigned, and in whose place Mr. William Hickson, of Lansdowne Lodge, was elected. On Mr. George Sandes paying up the entire of the last warrant for Clanmaurice, he applied for remuneration at the rate of one shilling in the pound, and the increased poundage was granted, also extended to all other collectors who would pay up. Mr. Stephen Sandes in Irraghticonnor, and Mr. J. Butler in Iveragh availed themselves of this advantage. The collectors in the other baronies presented for remuneration at ninepence in the pound, on the money collected; and contrary to expectation Baron Richarda fiated them .-The first instalment of the labour rate for Kerry was £5,730 which has been collected, except £954.
