vents in custody, whose petitions were not entered for the present commission.

If street-door letter-boxes were in a more general use at private dwelling-houses, the delivery of letters in this city, by the Post-office carriers, could be facilitated by two hours—a great convenience to the public. Mr. John Abraham, of this City, has just issued

a republication of his "Guide to the young farmer," expressly adapted to green crops and subsoiling. Coming from an experienced practical agriculturist, and seedsman, this little work must be welcome guest to all interested.

At Cork Assizes Baron Richards said he would direct the Grand Jury to present for the poundages on the sum collected by the barony constables, which was under the amount specified in the warrant.

Baron Richards fined the baronial collectors one fourth of their salaries for not making up proper

jury lists.

Lord Kilworth, High Sheriff of the County Cork, was fined £70 by Baron Richards, for not having sufficient bailiffs in court, to keep order and regularity.

Six barony constables for the county Cork are to be appointed this day by the Grand Jury. Two of the baronies, Bere and Bantry, were so desolate and destitute, that no collector could be got for them.

In the record of Richard Isaac v. George Bruce, tried before Judge Ball, at Cork, an action of trespass, to recover the value of two-thirds of a crop of wheat grown at Milltown, by plaintiff, the outgoing tenant, and which he contended it was the custom of the country to be allowed for, the jury found a verdict for £35. In the appeal case of Abraham Fisher, of Youghal, v. Marquis Downshire, upon the payment of tythe rentcharge, Judge Ball has confirmed the Magistrates decree against appellant, and decided that the two years limitation clause does not apply to the case.

Mr. Abraham Fisher, of Youghal, complains that the "hat" scene in Judge Ball's court was exaggerated for the purpose of rediculing conscientious scruples.

John P. Molony, of Craggs, Esq., is a candidate for the Coronership of Clare, vacant by Mr. Martin's death, in this City.

Catherine and Bridget Hearns, charged with robbing the gardens of the Rt. Rev. Dr. Haly, and Mt. Fishbourne, of Kelvin Grove, were sentenced by the Carlow magistrates to two months' imprisonment with hard labour.

Two farm dwellings, and two dairy houses, were last week maliciously set on fire in the parish of Kilcummin, not far from Killarney, and consumed with seven cows and several sheep. About ten days before possession of the farm was given to the landlord by the sheriff under a writ of habera.

A quarrel occurred, on Saturday, at Kanturk, between Michael M'Auliffe and Michael Barrett, in which M'Auliffe became so excited that he stabbed Barrett in the thigh, where he inflicted a dangerous

wound. M'Auliffe was apprehended.

Tuesday evening, as a keeper of Sir Robert Gore Booth's named Scott, at Lessidal, Sligo, was retiring for the ,night, he discharged his gun, which burst, and injured his left hand so badly that amputation was necessary.
