On Thursday the profession of Nuns took place in the Sisters of Mercy convent, Galway. The ladies dressed were, Miss Burke, of Limerick, and Miss Lynch, of Barna. The Rt. Rev. Dr. O'Donnell officiated. Lt.-Col. Huey and a few more officers of the 1st Regt. were present at the ceremony.

The Rev. Mr. Beere, Curate of Adare acknowledges with thanks the sum of two guineas from the Earl and Countess of Dunraven, for the West Limerick Distit Society.

R. C. Hickson, Esq. Fermoy, county Kerry, forwarded to his Excellency the Lord Lieutenant, during a royal visit, luxuriant specimens of oats, flax, mangold, and potatoes, grown on land over which he had sown about 18 months ago, and which he had planted under the "Land Improvement Act."—Since Albert expressed his admiration at the success of Mr. Hickson's experiment.

On Monday, the Sheriff and Police were engaged in taking possession of the lands of Corohan, county Galway, the property of R. A. H. Kirwan, Esq. where eight houses were levelled. On the same day three houses were levelled on the property of Mr. Oliver, at Killanckinny. On Wednesday, thirteen families were ejected on the Killaloony property, by order of the Court of Chancery; nine of the houses were knocked down. On Thursday, at Clonkeely and Duggera, the property of Crean Lynch, Esq., forty-three families were turned out, and eighteen houses levelled. On Friday, on the Belmont estate, 100 houses were taken possession of, 34 of which were thrown down. This property is also in the Court of Chancery.

Upwards of 150 ass hides have been delivered in Dublin from the county Mayo, for exportation to Liverpool. The carcasses, owing to the scarcity of provisions, had been used for human food.

A labouring man named Patrick Fallon was struck dead by lightning during the thunder storm on Saturday, whilst reaping at Donadea, county Kildare.

A farmer named Coughlan, near Tullamore, had his horse killed by the thunder storm, on Saturday last.

Two cows and a horse, which were grazing in a field near Shannon Harbour, were struck by the thunder and lightning on Saturday, and killed.

Robert Welsted, Esq. of Ballywalter, Castletown-Roche, has sold his extraordinary weight-carrying Tinker, to Mr. Hartigan, of Limerick, for 120 guineas.

Patrick Cormick, executed at Galway on Monday, for the murder of Miss Prendergast, made a confession of his guilt, and exonerating Phil. Donohue.

Copy of his confession—"I, Patrick Cormick, do of my own free will and consent, as I am now about to appear before my God, declare most solemnly that no other person than myself had any part in the murder of Miss Prendergast, and that Philip Donohue was not there, nor did he take any part in it, and I further state I was driven to crime by famine and starvation, having myself and my two brothers, and my mother, nothing to eat for three days previously but water cresses. PATRICK CORMICK."
