

#### QUARTER SESSIONS.

THIS DAY.—The civil business of the City being exceedingly heavy, the Assistant Barrister discharged the County Petty Jurors from attendance till to-morrow. The City Grand Jury will be sworn at nine o'clock same morning.

**FISHERY APPEALS.**—It will be in recollection that a few weeks since the Magistrates at County Petty Sessions, at the prosecution of the Conservators of the Shannon Fishery, convicted Stafford O'Brien, Esq., Patrick M'Namara, John Punch, Joseph Massy, Pattt Dwyer, John Hayes, and Joseph Greene, in penalties of £2 each, under the 5th and 6th Vic., for having weirs erected in portions of the river not thrcce quarters of a mile wide at low water of spring tides. Against these decisions appeals were lodged, the hearing of which came on this day before the Assistant Barrister. Counsellor Grayden appeared for the conservators, Messrs. Gleeson and Joynt for the appellants. After a full hearing of the case against Stafford O'Brien, Esq. the court affirmed the decision of the magistrates, with £5 costs; and against all the other parties, with £1 costs, his Worship intimating that the applicants could bring the cases before the Court of Queen's Bench, by writ of *certiorari*.

The Fishery conservators met to-day in the Grand Jury room of the County Court-house, Sir Richard de Burgho presiding. It was agreed to apply to the Lord Lieutenant for the liberation of John Mulqueen and Bryan M'Mahon, at present undergoing imprisonment in the county gaol, for breach of the fishery laws ; also to complain against the Kilrush magistrates, for refusing to aid the bailiffs in executing their duty by declining to sign warrants for recovery of penalties. An application is to be made for opening of the fishing season in February instead of March. A reduction of water bailiffs was recommended.
