On Thursday night, Sylvanus Bevan, master of the *Chandos*, left Tralee to get on board his vessel at the Samphires. He arrived on the cliffs at a late hour, and having hailed, his boat immediately put off, but on arrival in shore there could be no account of the Captain. Search was made that night and next day, when the remains of the unfortunate gentleman were found in a hollow at foot of the cliff, from which he had fallen, with his neck broken. What makes this event more melancholy is that deceased had been married to a young English girl, Miss Bowden, of Bristol, in Blenner-ville Church, on Christmas day last.

The *Eliza Sanders*, from Patras to Liverpool, took fire 15th inst. off Cape Clear, and was destroyed. Crew (except one man drowned) took the boat, and arrived at Liverpool.

Wednesday last, a pauper who stated that he was from Dublin, and formerly in the service of the East India Company, went into the shop of a baker named Sullivan, in Galway, to ask for alms and having been turned out he broke one of the windows. Sullivan beat the poor wretch in a fearful manner. He was taken to the workhouse Hospital, where he died. Sullivan has been committed to prison.

LIMERICK UNION.—The guardians met to-day, Mr. Cullen presiding. William Monsell, Esq., M.P., attended. A letter was read from the Commissioners sanctioning the appointment of the Rev. J. Ryan, C.C. St. John's, as chaplain to Clare-street auxiliary workhouse (where 500 female paupers are located), at a salary of £25 a-year. On the suggestion of Mr. Monsell the house committee were ordered to assemble for the purpose of selecting further additional premises in the city and liberties, suited for auxiliary establishments. Mr. Hogan informed the board that Wednesday last 580 paupers were admitted into the workhouse! The number of inmates in the different establishments this day, is 7,557; on out-door relief lists, 5,020; cost of same during week, £136; average weekly cost of Workhouse paupers, 11½d. per head; discharged during week, 180; died, 22.
