On Wednesday last, at Melton, near Kilmallock, in the 30th year of her age, Caroline Louisa, the beloved wife of the Hon. James O. Grant, J.P. son of the Earl Seafield, and second daughter of Eyre Evans, Esq. Ash Hill Towers, in this County. Seldom has it been our lot to record the death of a lady more universally regretted. Religious, amiable, unostentatious—every thing, in short, to gain and secure the esteem and affection of those who were her acquaintances. She has suddenly been cut off in the prime and loveliness of youth, leaving a blank in society, which cannot easily be filled up, and a sorrowing husband and child to bewail her irreparable loss—a loss which can only be endured by the remembrance of that resignation which at her last hour she evinced, in bowing to the will of Him, whose she was and whom she served. Her sudden removal has cast a general gloom over the neighbourhood in which she resided, and where she was known and loved from her childhood.
