The ship *Victoria*, of Limerick, chartered by Mr. John Sidly, to tranship the passengers from the *Jane Watson*, emigrant vessel, from Galway, lying at Kilrush, was maliciously bored before leaving our quays, by some diabolical ruffians, at present unknown. The vile act was discovered at Kilrush, where the *Victoria* had to run ashore, in consequence of making water the entire passage down. Capt. Ellis, Government Emigration Agent, had previously inspected, and reported most favourably of the *Victoria*.

A new yacht belonging to the Marquis Conyngham has arrived at Scatterry; she is a magnificent vessel, over 200 tons, and crew of 20 men.

The number of prisoners brought before the magistrates of the city by the police was 2288 for the last four months, ending this day, averaging weekly 134.

WORKHOUSE, SATURDAY.

Sir Richard de Burgho presided at an extraordinary meeting of the Guardians, convened to consider what steps would be taken to prevent the remainder of the workhouse effects being sold by the sheriff. A letter was read from Mr. E. O'Connell, informing the board that the articles he bought at Thursday's auction were at their command, as he did so to prevent the property passing away to others. Mr. Murphy, solicitor, stated the sheriff was willing to abandon the sale provided he got 100%, and a guarantee that balance be paid within a month, or the goods under seizure forthcoming if required. Sir David Roche, William H. Barrington, and Mr. E. Bernard consented to join in a bill for 100%, and the necessary guarantee was given that the workhouse effects should be forthcoming. Mr. William O'Connell, who is also a creditor, kindly consented to hold over execution for a month. It is expected a full board of guardians will attend next Wednesday.

DEATHS.

On Monday last, at his house, Baggot-street, Dublin, in a very advanced age, Arthur Vincent, Esq. the senior Alderman of the late Corporation of this City.—A gentleman whose eminent virtues in private life, and endearing social qualities, secured the esteem and affection of a large circle of relatives and friends, who will long venerate his memory.

On Sunday morning last, at Victoria Terrace, in simple reliance on the merits of his Redeemer, Hugh Frederick Finch, second son of the late Hugh F. Finch, Esq. of Maryville, in this County. His remains were this morning interred in the family vault at Nenagh.

Yesterday, at the Island, Mrs. Blair, relict of J. Blair, Esq. Lieut. 88th Regt. and mother-in-law to the Rev. John Elmes, Vicar of St. John's.

On Sunday morning, at the residence of his father, Dr. Gore, 89, George's-street, William Ringrose Gore, aged ten years and five months. This dear child died in the sure and certain hope of everlasting life through the merits of the Lord Jesus Christ, and with calm resignation to the will of his Heavenly Father.

Yesterday morning, aged 56 years, the Rev. Daniel Lyddy, P.F. of Ballygarry—a clergyman greatly and deservedly respected by the clergy and laity of the diocese of Limerick. The dignity of the priestly office in his person shone with bright unchanging lustre—it was fed by the lamp of Christian charity, and strengthened by sincere attachment to the hallowed duties of his Apostolic mission. The remains of the Rev. gentleman will be interred to-morrow in the new Chapel of Abbeyfeale, which is a monument of his piety and zeal for the glory of God.

A Correspondent writes—"For many months past his disease, which was an affection of the heart, assumed a very serious aspect, leaving but little hope to his numerous friends that a life so precious would be spared. With perfect calmness and resignation did he during this trying period await the awful moment when it may please the Almighty Disposer of events to summon him out of existence. In him were combined the urbanity of the gentleman, the learning of the scholar, and the unostentatious piety of the Christian."
