Your note of the 31st ult. only reached me
 I regret that it is not in my power to give
 you information respecting Mr. John Ball. I
 am not of the Borough of Carlow, not of the
 county so that I know but little of him that is not
 known to the public.

Mr. Ball was returned in 1852 for the County, a per-
 former, through the then great influence of John
 Ball, when the whole Conservative interest of the
 county was brought out, not so much against Mr.
 Ball as against the power of Sadleir, Ball having
 been looked upon as merely the nominee
 of Mr. Sadleir. Before he was twelve months in Parlia-
 ment the part he took on the Income Tax was so
 unpopular to the great bulk of his supporters, that the
 majority of Carlow would just as soon be returned
 as Mr. John Ball. He, therefore, never
 mentioned himself publicly since for the County or
 county, but it is well known to many that he made
 a run through the County before the
 election, to see if he had any chance; but the few
 who consulted (and they were friends) told
 him it out of his head. So no more was heard of
 him in Carlow, nor never will.

On the other hand, I have been told that his con-
 siderable and most sincere and earnest supporters
 has been most offensively supercilious.
