In the discharge of a duty which is that of a messenger of good to men he has worked incessantly-nothing daunts him-no assembly however numerous or aristocratic in appearance blanches his cheek or shakes his nerves. St. Paul fought with lions at Ephesus, and it seems the man of whom we now speak has steeled his nerves by combat, for nothing dispirits him. The scoffer stands rebuked; the sneerer becomes a serious and an attentive listener, and finally finds himself applauding the man whom he came prepared to revile. In England, where he visited the collieries, in discharging the duties of his missionary calling, he has made known to his ignorant countrymen and whilome fellow-labourers the plain and simple religion of the Redeemer, who came to call sinners to repentance by preaching the gospel to the poor, and in this way those who appeared to be neglected by their fellow men have had the path to salvation pointed out to them by this confessedly uneducated, but powerfully energetic man, at who, undoubtedly, has thrown his whole soul into the ted work before him. In his several discourses he gave no offence to any; he did not traduce the Roman Catholic; he did not exalt the Protestant; he did not magnify the Presbyterian; he did not stand hand and 8tn glove in the Methodist. No; his doctrine is love to all mankind through the Lord Jesus. He combatted and on nothing but sin, and a disbelief in the all saving merits off of "the Lord who bought us." 3ke
