The case closed, and the Mayor having consulted with the justices, said-"The bench has given this case the fullest consideration, and we must say that it was a very proper case to bring before the court, for although the evidence has failed in attaching guilt on the prisoner yet, it is one of great suspicion, because the article was carried away from the house of Mrs. Cooper, but on the whole case there are such circumstances throwing doubt over the allegation of guilt that the court is coerced to dismiss the complaint. TOBACCO. John Chambers, publican, Arthur's quay, was sued for penalties by the Commissioners of her Majesty's Customs, under the 16th and 17th Vic., cap. 107, sec. 232, for having on his premises, concealed in a drawer in a bedroom, a quantity of contraband tobacco. The penalty imposed for this offence is three times the value and duty of the article seized, or, at the eletion of the Commissioners £100; and in this case the Commissioners sued for the latter.

The tobacco which is called cavandish was produced, and was pronounced by connoisseurs of the weed and sclepts in the mystery of smoking to bewretched stuff, not even fit for fumigating a piggery.

The defendants neice was examined for the defence, and she deposed that her uncle keeps a ledging house for sailors, and that a sailor gave her the bundle to put by for him, and so she put it into the drawers in the bed-rrom which the sailor was to occupy, She did not know what it contained and her nucle did not see it at all. There was no concealment about it whatever.

The nacistrates held that under these circumstances there was no guilty knowledge on the part of the defendant, and dismissed the case.

EMIGRATION TO NEW ZEALAND.—The ship Chariot of Fame, 8,730 tons regisirar, of the White Star line, sailed from Gravesend on the 25th inst. for Lyttleton, with emigrants who had been provided and assisted with passages by the Provincial Government of Canterbury, consisting of 62 married couples, 46 male and 32 female children between one and twelve years old, and 32 infants, equal to 163 statute adults, 85 single women, and 66 single women—together, 314 statute adults. The Mermaid, belonging to the same line, which sailed on the 40th ult., had on board 15 married couples and their families, 44 single men, and 72 single women-together equal to 236 statute adults to whom assisted passages had been similarly afforded.
