DEATH OF THE REV. GEORGE M. MASSY. We deeply regret to announce the death of the above lamented clergyman, whose painful illness for the last fortnight, borne with extreme patience, caused such great apprehensions as to the result. The demise of so highly respected, kind hearted, and benevolent a gentleman, will be received with deep sorrow by all to whom he was known, for in every relation of life, as a minister of religion, a benefactor of the poor, and friend to the distressed without distinction of sect, he had no equal. Throughout life he lived in perfect peace and harmony with all classes, especially his parishioners, by whom he was revered and beloved for his uniform, courteous, and kind disposition, being at all times desirous to promote their interests to the utmost of his ability. The clergy of this diocese who knew and appreciated his zeal in the Ministry deeply deplore his removal from amongst them. The remains of the Rev Mr Massy will be interred on Monday morning, at seven o'clock, in Kilkeedy Church.
