which was shortly this. On the day in question dat. Haines sent his lad to his flour stores, which are situate in Bowdy-lane, to deliver 4 sacks of flour to a customer which duty being performed the young lad returned to his master's establishment in George-street having locked the store. Mr. Haines having some business at the store, for which he had a duplicate key, went there, and to his surprise found the prisoner loading his dray with the flour out of the stores, and of which he had three sacks ready to start away with—when arrested and searched no keys were found on him, but the Constable found the remains of two sacks of flour in his residence at Penny-well.

Mr. Haines was examined, and stated that he gave no authority to the prisoner to get this flour. he had his own drayman to deliver his goods to his customers, he admitted however that he often employed the prisoner, and had found him honest.

The boys in Mr. Haines employment were also examined, and they deposed that they did not give the prisoner any authority at any time to take flour

out of the store.

Mr. Doyle, who defended the prisoner, spoke to evidence, and produced witnesses who gave his client a good character. After which his Wordship charged the jury, who after some short deliberation found the prisoner guilty, and the learned Chairman sentenced him to 9 months' imprisonment with hard labour.
