The hero of the following sporting event is a young Kerryman, being a gradson of the late Rev. William Godfrey, Rector of Kenmare:—

An occurrence took place on the 11th inst. which has excited considerable interest among military and sporting circles. Lieutenant Thomas, of the 2nd bat-tallion of the 32nd Foot, stationed at Fulwood garrison lately alleged, in presence of some of his brother officers during mess, that he could walk, fully accoutred as a private soldier, and armed with rifle and bayonet, sixty miles within twenty hours.
