The justices placed the "poet" under a rule of bail, himself in £20, and two sureties in £10 each, or in default, six months' imprisonment.

The poet said that as Homer was persecuted and despised whilst living, he could not be exempt from similar treatment at the hands of his own countrymen, and therefore he would submit without complaining, but he hoped that the governor of the gaol would place him in the "poet's corner" during his sojourn under his superintendence. The poet then bowed to the bench, and retired to prison.

At Petty Sessions on the 12th instant, Martin Carrick and Frederick Considine, two of the Englishtown rowdies, were sentenced to two months imprisonment each, with hard labour, and bound to the peace for twelve months, for assaulting Mr. and Mrs. Kilmartin, in their spirit establishment in Athlunkardstreet, and Mary Blake, Bridget Considine, and Margaret Keatinge were also bound to the peace for violent and threatening language to complainants. In pronouncing judgment the Bench complimented Kilmartin for the resolute manner in which he and his wife met the attack of his assailants, whose conduct was most outrageous, observing that if publicans generally pursued a similar course, it would tend to uphold their respectability—Kilmartin had acted properly by himself and the public in the matter.

Doonas Petry Sessions-The Justices who presided at these Sessions on yesterday were W. Studdart Esq. (Chairman); J. C. Delmege, T. O'Brien, and George Gloster, Esqrs. Several cases of a local nature were disposed of but not one case of public interest was brought under the notice of the Bench.

In the Court of Common Pleas, Dublin, a verdict for £261 10s. was had for the plaintiff this week in the case of Michael Dundon v. Mary Mulcahy, of this city, dealer in American bacon, &c., and Mrs. Mulcany has instituted proceedings in the Court of Exchequer against Mr. Dundon, as she could not, on a plea of set off, claim credit for £150 alleged to have been expended in clothes for Mr. Dundon's children, and for other purposes. The defendant (Mr. Dundon) lodged £28 10. in court and traversed the allegations as to the amount of the money due, and also pleads that he paid the difference between £20 8s. and the sum claimed. The case has not concluded.
