His successors will profess the Orthodox religion. A committee of three members, chosen by the Ministry, will proceed to Copenhagen to offer him the crown in the name of Geek nation.

Prince Alfred has returned to England, and been welcomed with maternal tenderness by the Queen, who proceeded to the station at Windsor, accompanied by other members of the Royal family, on Tuesday evening, to await his arrival.
