LONDON CORN MARKET.

(Aste's Report.)

English wheat in bad condition, and expected to be cheaper. Nothing doing in foreign as yet. Oats a turn dearer; other spring corn about the same as this day week.

(Usborne's Report.)

English wheat more or less out of condition, and difficult of sale; good samples 1s lower on the week. Foreign, quiet trade, and to sell 1s cheaper; floating cargoes few arrivals, but samples and reports not yet received. Flour—Barrel scarce, and sell at late prices. Oats—Fine samples 6d dearer; other sorts full sale at last Monday's prices. Barley a turn dearer. Peas and beans as on Monday last. Maize in good demand at 30s, 48s for Ibrail, and 32s to 49s for Odessa and Galatz.

LONDON PRODUCE MARKET.

Sugar—Business limited; prices scarcely changed; refined quiet; brown lumps 44s. Coffee—Several transactions in Plantation Ceylon at extreme rates; few sellers; native at former terms. Tea quiet; holders firm. Rice—Little doing in white Bengal; fair trade in soft grain at full rates.
