The board is aware we never hesitate to pay all rates without trouble; and the result of this special revision, and the ordinary regision since, in which many more of our concerns were reduced, shew that we have for years paid large sums in excess of our fair liability. We. therefore, ask for the rebate of this £15 as a simple matter of justice.
