### LONDON CORN MARKET.

Thin attendance, owing to Punchestown races.—Home grain unaltered, except oats, which is 6d lower. Foreign wheat in fair demand, at very full prices.—Choice restricted. Indian corn 6d dearer. 31s for Galatz. Flour and oatmeal—Little business. Buyers have the turn in their favor.

Blondin figures as a creditor, for some £12,000 and it has been stated that the failure of the bankrupt is the cause of the reappearance of the talented artist in question in public.
