### DUBLIN CATTLE MARKET.

Ganly and Co's Circular.

Beasts, shown as fat, 2,748; but two thirds of the number only could with justice be called butcher's beasts. Sheep and lambs, including stores, ewes, and wethers, 5,434. Veal calves, 103. In the so-called store market 467 beasts were shown, but a large number of this class was sold in the pens before the hour of selling. In consequence of the report of a heavy, low market over the water, the necessity of the closing autumn season, and scarcity of grass for a large number on market, a reduction in beef of from 25s to 30s per head had to be submitted to, the best barely making 65s per cwt. Prime aged wether mutton, 8d; ewe and hogget, 7d to 7½d. per lb. Veal 6d to 8d per lb. Breeding ewes of ordinary quality were sought after, and fair prices given, at about 5s to 7s under last year, when panic stricken cattle feeders ran wildly into sheep, fearing the ginderpest, now, happily, nearly extinct, and Ireland free from even the suspicion of that epidemic.

The corn trade experienced a slight excitement during the last few days, which was by no means warranted by actual damage. The high winds accompanying the rains, steadily drying up the damp and preventing sprouting, no serious injury to affect prices has as yet been done.
