FRANCE

Paris, Nov. 21.—The Moniteur du Soir, in its bulletin, alludes to the recent acts of the Italian Government and the circular of Baron Ricasoli, and says:—The Florence Cabinet reproduces now the ideas so often expressed by the Government of the Emperor, whose efforts have always tended towards reconciling the national aspirations of the Italian peninsula with its religious sentiments. In presence of such a disposition on the part of the Italian Go-vernment, the Holy Father may look forward to the future with confidence; and there is every reason to believe that the extreme Pontifical parties will not prevail, and that the Court of Rome will show itself inaccessible to influence which, under the mask of false zeal, hides intentions prejudicial to the security and dignity of the Pontifical throne.

ITALY.

Florence, Nov. 21.-The King arrived here at one o'clock to day, accompanied by the Princes Amadeus, Humbert, and De Carignano. His Majesty was received at the railway station by the authorities. The troops and National Guard were under arms, and the immense crowd which had assembled greeted his Majesty with prolonged cheering. The streets are decorated with flags, and the city will be illuminated this evening.
