### LUNACY IN IRELAND.

According to the last report of the Irish Lunacy Inspectors, the registered lunatics in Ireland on the 31st of December, 1867, amounted to 9,086, showing an increase of 124 on the previous year's return. By far the most interesting feature of this report is a return which has been procured through the Irish Constabulary showing the number and location of lunatics at large throughout the country, that is of persons suffering from any form of mental disease whomre not placed in any of the institutions for the care and treatment of the insane, but who are living with and maintained by relatives or friends, or who are wandering without any fixed abode, and subsisting on charity. The total number of these "lunatics at large" is thus ascertained to be 6,564, which in addition to 9,086 patients under treatment, makes an aggregate of 15,650 persons of unsound mind in Ireland. Now, the population of that division of the United Kingdom was estimated to be in the middle of last year 5,557,196; so that it is now ascertained with considerable accuracy that one in very three hundred and fifty-five of the people of reland is suffering mental alienation, and is, or ught to be, the subject of special observation and
