of, the Court adjourned to the 3rd May.

At the Cork Police-office, yesterday, a discussion arose as to the right of the Mayor to discharge, on Sunday morning, persons charged with drunkenness. Mr Starkie, stipendiary magistrate, conceded the right, but stated that the prisoners should be summoned afterwards. The Mayor contended that he had the power to discharge them finally, and denied the right of the magistrates to interfere with his decision. He was answerable for his acts. An excited argument followed. The Mayor quoted precedent for his proceeding, and alleged that the question was raised to annoy him, and that if the Mayor were an Orangeman it would not be mooted. This assertion was flatly contradicted. The Mayor denounced the presiding magistrates as hostile to the people, and threatened that if the police issued summonses against the parties he discharged, they should do so at their peril. The occupants of the gallery applauded the Mayor, and bissed the other magistrates. The scene was altogether discreditable, and justified Mr Unkles' remark that Cork would become a by-word among the nations, and the court a burlesque.

SURRENDER OF M'KEANE.

On Saturday, Austin M'Keane, charged with firing at Thomas Horan, at Killshanny, near Ennistymon, arising out of a dispute concerning land, surrendered himself on Saturday to John B. M'Namara, Eq., J.P., at his residence Rooklodge, Liscannor. Mr. M'Namara at once accompanied the prisoner to Ennistymon, where he was conducted to prison. It town towards the jail M'Keane was loudly cheered by the people, who throughd in vast numbers to see him. The part taken by Mr. M'Namara in the matter is highly creditable to him, both as a magistrate and spirited gentleman.
