THE EASTERN QUESTION. TEXT OF PRINCE GORTSCHAKOFF'S

REPLY.

The following is the full text of Prince Gortschakoff's reply to Lord Granville, being a despetch addressed to Baron Brunnow, dated 20th November, 1870 :-

Monsieur le Baron,-The Ambassador of England has read and left with me a copy of Lord Granville's despatch in reply to our communication of October, 19th. I hastened to submit it to his Majesty the Emperor. Our august master was pleased to point out that it contained in the first page an expression of the earnest desire of the Cabinet of London to preserve cordial relations between England and Russia; and secondly, an assurance that the Cabinet would not have refused to enter into an examination of the Treaty of 1856, so far as it had been modified by circumstances.
