Dovle and Kenny defended the accused. On the last Court-day a charge of assault against Sub-constable Patrick Murray was before the Court, in which he was fined £5 and costs for assaulting Nash and two other men in Quay-lane on the 16th of August last; and it was arising out of this case that Sub-constable Dunne was summoned for neglect of duty on the occasion of the

Jeremiah Nash was sworn, and stated that on the 16th ultimo he was in company with two men named Quin and Cavanagh; Sub-constable Dunne was on duty in the street, when Sub-constable Murray came down in a drunken state and struck witness and the other two men on the head with a stick he had in his hand; witness called on Sub-constable Dunne to arrest Murray, but he refused to do so, and subsequently refused to give either his own name or that of Murray, when asked for them.

Mr. Doyle cross-examined the witness, and elicited the fact that when the assault had been committed by Murray he took hold of him and removed him from the crowd; he was quite positive that Dunne

refused his own and Murray's name.

John Cavanagh was next examined, and corroborated the evidence of Nash.

Mr. Doyle, in addressing the Court for the defence, said that only it was an important case to the public and to the Constabulary he would not detain the time of the Court in making any observations in addressing them, as he anticipated a verdict for the defendant would be given. He con-tended that Dunne did his duty on the occasion, for it would be rash and foolhardy for him to attempt to arrest Murray, who was either mad or drunk, and was armed with a sword and stick. He would prove by evidence that Dunne reported, as he was bound to do, what occurred to his superior

Constable Moriarty deposed that Sub-constable Dunne reported to him the conduct of Murray in committing the assault on the three men in Quay-lane, shortly after the occurrence.

Head-constable Robinson gave similar evidence. The Mayor inquired of Head-constable Robinson whether it was the duty of the sub-constable to give his name.

Head-constable Robinson replied in the affirma-

The Mayor said it was the opinion of the Bench that the defendant was guilty of neglect of duty, inasmuch as he had not facilitated the public in giving the name of the policeman who assaulted them, or of himself, and they were inclined to do nothing that would mar his future prospects. The nothing that would mar his future prospects. The Sub-constable might have been guilty of a little indiscretion in arresting Murray, but he acted very improperly in withholding his name from men who had been assaulted unwarrantably and unprovokably. He should therefore be fined 2s 6d.

Mr. Doyle applied not to have the fine recorded, inasmuch as if the Sub-constable were only found guilty of refusing the name of Murray, the police would deal with it, and as the recording of a fine would injure him very much.

The Mayor said the Bench could not accede to

the application. They were determined to deal out even-handed justice, to protect the police from lawlessness and the public from acts of aggression on the part of the police.
