She then went herself, and the defendant placed his back to the rick, and taking a weapon in his hand swore by his Maker that the straw was his property, and that he would defend it with his life, and when witness was about to proceed to the rick he threatened to knock her down; he also

boasted of having a pistol in his possession.

It was urged by Mr. Connolly, on the part of the defendant, that the property sought by the plain-tiff was not her property at all, and that he was perfectly justified in not letting anybody take it.

The Bench dismissed the case without prejudice, inasmuch as the rightful ownership of the property was disputed.
