EXCLUSION OF MR. BRADLAUGH.
 Majority of 191 votes approving the action with respect to the exclusion of Mr. Bradlaugh yesterday was composed of 111 Home Rulers and 80 Conservatives. Government whips acted as tellers, and the majority of Liberals left the House without voting. Among the members of the Government who did not vote were Messrs Bright, Shaw, Lefevre, Trevelyan, Sir James Campbell, Bannerman and General for Ireland.

ORDINARY OCCURRENCE.

An occurrence was occasioned in Linton this morning by the discovery on the steps of the house of what was supposed to be an explosive, consisting of a tin canister with a piece of wire inserted through the hole. On being opened it was found to contain a quantity of tarrad rope and a quantity of powder resembling gunpowder, but which was not of the kind, and a lump of hard white substance. It is supposed the affair is connected with the late explosion.

CRIME IN DUBLIN.

The Dublin Commission to-day reported that in the county and city there had been a decrease in the crime of three per cent. This he is unable to account for.
