THE Cork Butter Exchange is at the present moment not merely desirious to justify itself in the eyes of the agricultural public, but notably it is also anxious to recover its lost prestige in British and Foreign markets. In reply to the several well-substantiated charges laid against it by the members of the butter trade in Tipperary and Clonmel, the Committee of the Cork Market has published in its defence a lengthened statement, which we inserted by request in our last issue. Lest, however, this laboured refutation should prove ineffectual, Mr. CLANCY, of Cork, who is deeply interested in the success of the butter trade in that city, has published an imposing tabulated compilation, which if accepted must go far towards proving that the Irish butter trade was never more prosperous than it is at the present moment, nor Irish butter more appreciated. Unfortunately, specious arguments will go but a small way towards proving that two and two make five, or towards imparting to autumnal decay the freshness of springtide. Figures showing that the average price of butter during the ten years from 1841 to 1851 was only 84s, while the average from 1871 to 1881 was 131s, does not in: the least go to prove that the character of Irish butter had improved in the interim, or that Irish markets were in the least better managed in 1881 than they were in 1841. The charge which those who have the true interest of the Irish butter trade at heart is not that this most important agricultural produce has deteriorated in quality, but that it has not kept pace either in the form in which it is presented to the public, or in fineness of make, with the produce of other nations. In spite of all the arguments which the Cork merchants can adduce, some of the best markets in the world are completely closed against us in consequence of our inability to compete successfully with the more attractive productions of France and Belgium! A very few years ago the exportation of fine butter from Cork to Lisbon was a trade of the largest and most profitable character. At the present moment we believe it is actually non-existant. 🛕 very few years ago, Cork butter in the markets of London stood second to none; to-day the Cork brands are considered less reliable than those of Normandy, which are undoubtedly the least appreciated of Continental Western Europe. All this, however, cannot be justly laid at the door of the "close system," which unfortunately rules in Cork. It is more particularly what has been the effect of the Cork system upon the agricultural interest throughout the south of Ireland that we have now especially to deal. Undoubtedly that system has worked most detrimentally, and has proved most adverse to any improvement taking place in the quality 2 and character of Irish butter. A statement has recently been made in the Statist a journal which makes no statement unadvisedly, to the effect-"The Cork market suits careless " producers very well. It saves them all trouble, " and roughly classifies a great deal of produce " which would have difficulty in finding a market on its merits." But just because it suits people who are content with moderate returns, so long as they are not required to take too much trouble. it does not suit people who want to do the best they can, and who want also to obtain the best reward for doing it. We sincerely hope that the Cork Butter Market may be remodelled with a view thoroughly to meet the requirements of the present day so as to ensure that those regulations which now appear to be framed wholly in the interests of the brokers and exporters, may in future benefit that class which hitherto have been only too much ignored—the producers. At the same time we cannot see why Limerick, whose character each year rises in the scale, cannot seize the vantage ground, and while Cork hesitates to do what is right, occupy the premier place to which circumstances and position justly entitle it.

SUDDEN DEATH On Saturday night as Mounted Sub-constable Sproule, stationed at the William-street Coustsonlary Barracks, was proceeding from the County Inspector's residence at the Prescent, where he had been on despatch duty, to William-street Couhad been on despatch duty, to William-street Constablary Barracks, at about 11 o'clock, when he observed a number of men congregated near the County Club House, and suspecting that they were intent on illegal purposes the constable asked them what business they had to be out at such an unseasonable hour. The party then ran away, and the constable following at a good pace arrested a man named John McNamara in Glentworth-street. On the arrest being made it appears that McNamara at once struck Sub-constable Sproule on the face with his clenched hand. Subconstable Sproule and McNamara then had a jostle, and after a time Sub-constable Sproule succeeded in pacifying his prisoner and they both walked along George-street until they came opposite the Club-house where again M.Namara became disorderly and again jostle I with the constable, who called out "Police," when four constables, who were in plain clothes duty, came to his assistance, and safely conveyed their prisoner to William-street Barracks, where Sub-constable Carroll informed the Constable of the Juard that he kn we the prisoner, and would go buil for his appearance at pet y sessions.
