**DEED LAND LEAGUE HUNT AT MURROE.**

(FROM OUR REPORTER.)  
 Murroe, Saturday Evening.  
 Days past notices have been extended throughout the districts of Castleknock, Murroe, Newpallas, and Tipperary and Nenagh, imperatively commanding the people "to assemble in their own districts on the estate of Sir Croker Barrington, Murroe, for the purpose of holding a League Hunt." The constabulary in all the districts referred to, on having been informed of the existence of these notices, once took them down, and reported to the County Inspector, at Limerick, and, of course, forwarded these reports to Mr. Lloyd, Special Resident Magistrate, at Limerick. Mr. Clifford Lloyd, with his usual authority took steps to prevent the occurrence of the "hunt," and, if an occurrence, measures were taken for its suppression. Accordingly, at an early hour on Saturday morning, a large force of police—infantry and constabulary—paraded at the Constabulary barracks at Murroe. At 9 o'clock Mr. C. B. O'Connell, J.P., and Mr. E. B. Powell, M.P., were up on a car to the police barracks and in a few minutes afterwards they proceeded to the station. Mr. O'Connell, B.M., Limerick, escorted by a detachment of constables, arrived at the station in time to say that in face of the imposing force of police, no gathering was even attempted. The police, who were under the command of Sub-Inspectors O'Connell and McClelland, remained all day on duty, and left just before night fell. I add that the most friendly relations have been maintained between Sir Croker Barrington and his tenants. Sir Croker has not only given his tenants a large abatement in their rents, but has also abated the rents of leaseholders on the estate.
