ANGLING ON THE SHANNON.

Though the season opened here on the 1st, yet up to the present no fishing has been one owing to the floods. The roads near the Shannon Hotel, the Castle, and the Spa are covered with water. As I write this there is a lost seasonable change for the better. Yesterday and the previous day there was a brilliant sunshine which it is hoped may continue, as fishing operations, and, in fact, almost all outside work, are at a stand still. Fishermen have taken advantage of the sunshine, and can be seen busily engaged looking after and repairing their tackle and mending their nets." I was, to-day, told by the oldest fisherman here, "Johnny," that he never remembered seeing so much spawning fish he did this year, and he predicts a brilliant angling season, and gives the reason for his prediction, "that the water was so high no poaching in any account could be carried on."
