THE CLARE CRAG FARM CASE.

The Dublin Court of Appeal, yesterday, gave judgment in what is known as the Clare Crag O'Brien, tenant; White, landlord. The tenant held 315 acres of land in the county Clare. The land is covered to a great extent with boulders, and between the boulders there are patches of grass which are valuable for grazing. The farm, as it stands, would hardly be used as an ordinary agricultural farm, but at a large expense, by blasting the boulders and so forth, it could be used as an agricultural holding. The tenant had held under an agreement for a lease down to 1879, when he became a yearly tenant, but the agreement did not contain any express covenint that the farm was to be used in any particular way. Mr Commissioner Reeves held that, notwiths anding this fact, the farm being ordinarily incapable of being used for anything but as a pasture farm, must be taken to have been let to be used for purposes of pasture, and dismissed the originating notice to fix a fair rent. The land commission reversed this decision, and the landlord appealed. The Court of Appeal now unanimously reversed the decision of the land commission, holding that Mr Reeves was right.

Mr W E Counihan appeared for the accused.

Mr Connolly, who prosecuted on behalf of Messrs Denny, said the assault was connected with the strike of pork putchers which took place in September last, because the men assaulted were amongst those who remained at their work on the occasion of the races.
