

The Rev S Saxby, a Somersetshire vicar, who had known the plaintiff for 37 years, said he never heard anything against him.

The Rev J Langridge, of John's Hammersmith, who attended plaintiff's late wife during her last illness, stated that he saw nothing to justify the statement that unhappiness existed between plaintiff and the late Mrs Adams.

Friends of the late Mrs Adams denied that her marriage was an unhappy one.

The plaintiff then went into the witness box and gave an outline of his history. He said that after his wife's death he became secretary to the Anti-Vivisection Society, where he met Miss Coleridge. When calling on Lord Coleridge by request, the witness objected to the defendant's presence.

The Hon Mildred Coleridge tendered her evidence, but she was not sworn.

This closed plaintiff's case.

The Attorney-General declined calling witnesses. He claimed that the letter was privileged.

Mr Justice Manisty thought so too.

The plaintiff addressed the jury.

Mr Justice Manisty decided to let the case go to the jury, reserving the point of law for himself to decide as to the legal evidence of malice.

The Jury gave a verdict for plaintiff for £3,000 damages, but the Judge ruled the letter was a privileged communication, and gave judgment for defendant with costs.

ACTION FOR LIBEL.

In the Court of Queen's Bench to-day, Mrs Blood, mother of Lady Colin Campbell, obtained a verdict of £1,000 damages against the editor of *Modern Society*.
