FUNERAL OF THE ARCHDEACON OF KILLALOE.

The interment of the late Ven Archdeacon French, whose lamented death occurred on Thursday last, took place at Castleconnell, yesterday, the remains of the Archdeacon being buried in the churchyard of that village. The funeral cortege left the Rectory at 9.30 o'clock, the coffin being followed by a very long procession of carriages and pedestrians, which showed the high respect in which the deceased was held by his acquaintances. The chief mourners were Mr Riversdale French, Mr Raymond French, and Mr Arthur French, sons of deceased; Major Moloney and Mr Moloney, brothers-in-law. The clergy of the dioceses of Killaloe and Limerick were represented by the Lord Bishop of Killaloe, Dean Humphreys, Dean Robins, Dean Bunbury, Rev Chancellor Vereker, Revs G M Luther, R P Baylee, C Ward, and M E O'Malley. Amongst those who paid the last tribute of respect to the deceased's memory were Lord Massy, Capt Vansittart, JP; Capt O'Grady, Mr R J Gabbett, JP; Mr C G Vansittart, Lieutenant Osborne, Colonel Vandeleur, JP; General Fraser, Mr Alexander Bannatyne, Mr J F Bannatyne, Mr U Bourke, B.L, and Mr E Bourke. The coffin, which was covered with choice wreaths and was borne from the rectory to the burying place by willing hands, was met at the entrance of the church by the Bishop, Dean Robins, and Rev Mr Vereker. In the church, which was draped in black, the Bishop read the Burial Service, and the appropriate hymn, "O God, our help in ages past," was most impressively sung by the choir. As the cortege left the edifice the organ pealed forth in solemn tones the Dead March in Saul. As the mortal remnant of a valued friend and a loving and beloved pastor was lowered into its last resting place, scarcely a tearless eye was observable amongst the large number who gathered round the grave.

We have been requested to state that Archdeacon Hamilton was unavoidably prevented from attending the funeral, in consequence of having to officiate at the interment of Mr De Burgh Whyte, which took place at the same time in Limerick.
