#### DEATH OF DR. LYSAGHT.

This is the third occasion on which within the short space of a week that it is our melancholy duty to refer to the death of a Limerick physi- cian. Just as he was about to enter on a career full of promise and full of hope, on Sunday night Dr Lysaght, eldest son of the late Mr William Lysaght, J.P., fell a martyr to duty. He con- tracted scarlatina from one of his patients, and after a few days' illness succumbed to the deadly disease at the early age of twenty-six years. Dr Lysaght was one of the most distinguished students in his year of the British Medical School. His student career was characterised by a singular devotion to his work and rectitude of character. On obtaining his degree in 1885 he was immediately appointed medical tutor at the college of which he was formerly a pupil. This post he held for about a year, when he resigned it to proceed to further study at the London Hospital, to the great regret of his colleagues and pupils, who showed their appreciation of his sterling worth by presenting him with a hand- some testimonial. Last May he was unanimously appointed house surgeon at the Royal Infirmary, Bristol, where, in the performance of his duty, he fell a victim to disease, which almost imme- diately proved fatal.

#### DEATH OF MR CRUISE.

It is with much regret we announce the death of Mr Edward Cruise, which took place at his residence, Sunville, yesterday, after a short illness. The deceased was one of the most respected citizens of Limerick, and for many years a well-known figure in the commercial world. He was for many years concerned in an important local enterprise, and in consequence of his great energy and business capacity, the name of Cruise is now recognised almost in every part of the United Kingdom and outside it. Mr Cruise was one of those old citizens who connected the prosperity of Limerick with that of the past, and his death will be regretted by his numerous friends and by all with whom he came in contact during a long and honourable career. Almost up to the last he took an interest in the ordinary affairs of a citizen, though it must be said he took little part in politics or made himself in any way conspicuous in public life. Mr Cruise was a great traveller, visited almost every place of importance in the Continent of Europe, and generally brought back many interesting *souvenirs* of his tours. Mr Cruise lived to an advanced age, and beyond the usual span of human years. The funeral, which will be a private one, will take place on Thursday morning at seven o'clock.
