THE NEW RATE

On the subject of the new rates for the ensuing year a discussion among the guardians, led to a reduction of the estimate on his own divisions.

In the western divisions the long continuing dispute inspired from time to time, but which was uncollectable, brought the representatives of the divisions to their feet, who blamed the assessors and everybody connected with them, which they alleged, had for the past year created a very embarrassed state of the Union.

The estimate was, however, signed at last. **MILITARY STATE OF LANES IN KILKEE.** Reports were received from Dr P. C. O'Connell, medical officer of the Kilkee dispensary, in reference to dangerous nuisances in that town.

Dr O'Connell, J.P., said he drew Mr Keane's attention to the matter, but that he only turned on him and said the road contractors were to blame. The sanitary officer denied that he made any report on Mr Cox, but it was his duty to be making reports of nuisances to the sanitary officer, and these reports were read here.

Dr O'Connell said the Kilkee guardians denied that any blame could be attached to Keane. Dr O'Connell, J.P., said Mr Cox pointed out to him the dangerous state of a lane leading to Mr Cox's yard.

On some discussion an order was made to the sanitary officer to serve notices on the proprietors of these places to abate the nuisance within the prescribed time.

EVICION NOTICES.
