**FUNERAL OF THE LATE MR. WILLIAM HEFFERNAN.**

The funeral of the late Mr William Heffernan, a well-known and highly-esteemed member of the local Press, took place yesterday morning. The cortege, which was large and representative, left 3, Lord Edward Terrace, Roxboro' Road, at nine o'clock, for Mount St Lawrence Cemetery. A great many friends attended from a considerable distance to pay a last mark of respect to Mr Heffernan's memory, and to join with numbers of the citizens in expressing sympathy with his wife and young family in the great affliction with which it has pleased Providence to visit them. **ENNIS PETTY SESSIONS—FRIDAY,**  
(FROM OUR CORRESPONDENT).  
The weekly court was held to-day after a fortnight's adjournment. The magistrates on the bench were—Mr F. G. Hodder, R.M. (in the chair), Mr John W. Scott, and Mr Thomas O'Gorman.  
The cases heard, though numerous, were not of importance.  
Martin Hanrahan and John Nealon were brought forward at the suit of Head-constable O'Halloran, charged with being two of a party, who on Patrick's Day, violently assaulted a man named Roughan, in the yard of a publichouse in Ennis, for which offence two men named Mooney and Wall, were prosecuted a month since, and sentenced to fine and imprisonment. Several witnesses were examined by the Head-constable, and cross-examined by Mr Thomas Lynch, solr., for defendants.  
After a long investigation the case against Hanrahan was dismissed, and Nealon was fined 15s and costs.  
Michael Russell, for using obscene language in the streets, was fined 10s or a fortnight's im-
